

“Wandering Donut Giveaway” - OFFICIAL RULES

By participating in the “Wandering Donut Giveaway”, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Beacon Credit Union, which shall be final and binding in all respects. Beacon Credit Union is responsible for the collection, submission or processing of Entries and the overall administration of the “Wandering Donut Giveaway”. ELIGIBILITY: Open to legal residents of the Beacon Credit Union Service Area who are at least 18 years of age. Beacon Credit Union employees, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees, are ineligible to enter the “Wandering Donut Giveaway” or win a prize.
