

## Beacon Credit Union “Make It Home Makeover” - OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. MAKING A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.

1. PROMOTION DESCRIPTION: The “Make It Home Makeover” begins on February 14th at 12 noon and ends on May 31st at 12 Midnight.

The sponsor of this Sweepstakes is Beacon Credit Union. By participating in the “Make It Home Makeover”, each Entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Beacon Credit Union, which shall be final and binding in all respects. Beacon Credit Union is responsible for the collection, submission or processing of Entries and the overall administration of the “Make It Home Makeover”. 2. ELIGIBILITY: Open to legal residents of the Beacon Credit Union Service Area who are at least 18 years of age. Beacon Credit Union employees, and their respective parents, subsidiaries, affiliates, distributors, retailers, sales representatives, advertising and promotion agencies and each of their respective officers, directors and employees, are ineligible to enter the “Make It Home Makeover” or win a prize.

Household Members and Immediate Family Members of such individuals are also not eligible to enter or win. “Household Members” shall mean those people who share the same residence at least three months a year. “Immediate Family Members” shall mean parents, step-parents, legal guardians, children, step-children, siblings, step-siblings, or spouses. Winners must be in good standing with Beacon Credit Union if they have been or are currently a member. Winners that have caused Beacon Credit Union a loss are not eligible to win. The “Make It Home Makeover” is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

PRIZES: Grand Prize: 1 winner will receive a \$5,000 total package of interior design services that will include the professional design services and additional materials to compete a “Room Makeover”. Said makeover value will be determined by the current rate of professional services and reasonable expense of materials as determined by the chosen designer.

Only one prize per person and per household will be awarded. Prizes cannot be transferred, redeemed for cash or substituted by winner. Beacon Credit Union reserves the right in its sole and absolute discretion to award a substitute prize of equal or greater value if a prize described in these Official Rules is unavailable or cannot be awarded, in whole or in part, for any reason. The ARV of the prize represents Beacon Credit Union’s good faith determination. That determination is final and binding and cannot be appealed. If the actual value of the prize turns out to be less than the stated ARV, the difference will not be awarded in cash. Beacon Credit Union makes no representation or warranty concerning the appearance, safety or performance of any prize awarded. Restrictions, conditions, and limitations may apply. Sponsor will not replace any lost or stolen prize items.

The “Make It Home Makeover” is open to legal residents of the Beacon Credit Union authorized service area and Prize will only be awarded and/or delivered to addresses within said locations. All federal, state and/or local taxes, fees, and surcharges are the sole responsibility of the prize winner. Failure to comply with the Official Rules will result in forfeiture of the prize.

4. HOW TO ENTER: Enter the “Make It Home Makeover” during the Promotion Period online, by filling out the entry form at any Beacon Credit Union retail branch, and at the Beacon Credit Union official website which can be found at [www.mybcu.org](http://www.mybcu.org).

Automated or robotic Entries submitted by individuals or organizations will be disqualified. Internet entry must be made by the Entrant. Any attempt by Entrant to obtain more than the stated number of Entries by using multiple/different email addresses, identities, registrations, logins or any other methods, including, but not limited to, commercial contest/sweepstakes subscription notification and/or entering services, will void Entrant’s Entries and that Entrant may be disqualified. Final eligibility for the award of any prize is subject to eligibility verification as set forth below. All Entries must be posted by the end of the Promotion Period in order to participate. Sponsor’s database clock will be the official timekeeper for this Sweepstakes.
