Promotional Period for Introductory APR - Visa Black and Visa Rewards:

The Introductory APR for balance transfers will apply to the initial balance transfer made between 08/01/2020 and 09/30/2020 . To qualify for the Introductory APR for balance transfers, your requested balance transfer(s) must total no less than \$2,500.00. Any existing balances on Beacon Credit Union loan or credit card accounts are not eligible for the Introductory APR for balance transfers.

Loss of Introductory APR:

We may end your Introductory APR for balance transfers and apply the prevailing non-introductory APR if you are 60 days late in making a payment.

For California Borrowers, the Visa Black, Visa Rewards and Visa Blue are secured credit cards. Credit extended under this credit card account is secured by various personal property and money including, but not limited to: (a) any goods you purchase with this account, (b) any shares you specifically pledge as collateral for this account on a separate Pledge of Shares, (c) all shares you have in any individual or joint account with the Credit Union excluding shares in an Individual Retirement Account or in any other account that would lose special tax treatment under state or federal law, and (d) collateral securing other loans you have with the Credit Union excluding dwellings. Notwithstanding the foregoing, you acknowledge and agree that during any periods when you are a covered borrower under the Military Lending Act your credit card will be secured by any specific Pledge of Shares you grant us but will not be secured by all shares you have in any individual or joint account

with the Credit Union. For clarity, you will not be deemed a covered borrower if: (i) you establish your credit card account when you are not a covered borrower; or (ii) you cease to be a covered borrower.

Other Fees & Disclosures:

Late Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less, if you are 15 or more days late in making a payment.

Balance Transfer Fee (Finance Charge) - Visa Black, Visa Rewards:

3.00% of each balance transfer. However, this fee is waived on all balance transfers requested after the promotional period.

Cash Advance Fee (Finance Charge):

2.00% of each cash advance.

Returned Payment Fee:

\$25.00 or the amount of the required minimum payment, whichever is less.

Card Replacement Fee:

\$5.00.

Document Copy Fee:

None.

PIN Replacement Fee:

\$5.00.

Statement Copy Fee:

\$1.00.

Rush Card Replacement Fee:

\$50.00.

Rush PIN Replacement Fee:

\$50.00.
